

Terms Proposal - March 7, 2018.

Parties leaving GP and associated partners - MacKenzie McFee and Cori Ruff

The intent of this agreement will be to assure all parties involved have a mutual termination of partnership that does not unnecessarily harm any parties.

In agreement with Terms, presented by Cori and MacKenzie, they will not stream on any platform for 30 days from the agreed upon terms. If agreed upon, these dates can begin on the date of notification 3/4/18 and extend through 4/4/2018. This brief period would allow for the parties at Girls Play to restructure workload and practices.

In addition, from 4/4/2018 through 6/4/2018 MacKenzie and Cori agree to work with Girls Play and all parties involved in a positive manner that will allow a friendly and supportive collaboration. Beginning on 4/4/2018 through 6/4/2018 as agreed upon, Cori and MacKenzie will not stream during times in which Girls Play is live.

To a reasonable degree they will consider the schedule and not overlap with GP or any parties involved at GP. Should a GP stream exceed 6 hours, MacKenzie and Cori may stream overlapping GP but must first notify Sydney Larson via text or phone call that that they will begin a stream that will overlap. Doing so all parties can help give verbal support to each other. Demonstrating a respect for all parties involved.

If MacKenzie and Cori start a stream before a scheduled GP Stream, they agree to end their stream with a minimum of 60 minutes before GP's scheduled start time. A scheduled stream for GP must be made known to MacKenzie or Cori with a minimum of 48 hours' notice.

Between 4/4/2018 – 6/4/2018 MacKenzie and Cori agree not to work with, collaborate, or host any channel that has previously caused harm to Girls Play. They agree to work with Sydney Larson on identifying channels/parties in question.

Until 3/18/2018, MacKenzie and Cori are still employed at GP per their letter. They will continue to behave as employees. They do not expect compensation for the remainder of their employment. Effective per this proposal, they may not disclose they are leaving the channel to any non-informed parties until they make a public statement with the parties at GP.

Until 3/18/2018 ends, they will make no further attempts to recruit Moderators, or assistance to form a new channel from any known to be in the GP Community prior to the end of their "two-week notice" letter. Doing so would undermine the supportive and friendly collaboration all parties wish to have.

All parties at GP will not make any public statement beyond agreements made in person by MacKenzie and Cori regarding their departure from GP and its associated partners. We will support the decision made to leave GP.

Mackenzie and Cori will not attempt to coerce any people away from supporting GP. They will not spread information by their previous knowledge in GP, or by others who are spreading hurtful or damaging information. GP and parties involved will agree to the same for Mackenzie and Cori and their channel.

Cori and Mackenzie will tell the community that they have decided to leave Girls Play themselves though they will wait to announce any interest in forming an independent channel until after the date of employment on 3/18/2018. Cori and Mackenzie may announce by video or stream they are leaving GP but must be by EOD 3/11/18.

All monies owed by each party will be paid in full by EOD 6/4/2018.

GP to Cori: **\$20.75** receipts provided


Monies owed to GP by Mackenzie will be only for the Photo shoot in the amount of: **\$290.00**

Monies owed to GP by Cori for a total remaining amount of: **\$1,636.10** receipts provided


We appreciate the willingness to be sensitive to needs on both sides. We are willing to agree to the above terms should you both accept.

Terms amended 3/8/2018- Mackenzie and Cori


Terms amended 3/8/2018 (9:39pm PST)- Sydney
